REGISTERING YOUR ACCOUNT To register for an account, you will need your Participant ID number.

Once you register for an account, you will receive a notification with your PIN number. This is required to complete your account registration.

1. **Click Register**
2. **Enter requested information**

If you opt for an emailed PIN, you should receive it within 20 minutes. Otherwise, your pin will be mailed to you.

DOCUMENTS

When accessing documents online, it is important to remember the following:

- Six months of documents are available to view.
- If you are a Person Paying Support via an Income Withholding Order (wage assignment), a billing statement will not be available.
- If you are a Person Receiving Support and your case has not received a payment during the month, a Monthly Statement of Collections and Distribution will not be available.
- We must have a valid mailing address to generate your online documents.
- The California Department of Child Support Services will notify you via email when your document is available online. If you are enrolled in eCommunications, you are responsible for notifying us if you change your email address.

eCommunication Details

Documents

- Annual Service Fee Notice: This statement notifies the Person Receiving Support about the annual service fee and information related to the assessment.
- Child Support Warning Notice: This notice informs the Person Paying Support of delinquency and enforcement actions.
- Monthly Billing Statement: This statement details for the payments made and account balances for the month for the Person Paying Support.
- Monthly Statement Of Collection And Distribution: This statement details collections received and distributed during the month for the Person Receiving Support.
- Notice Of Intent To Close Case: This notice informs the Person Receiving Support that the case is scheduled to close in 60 days.
- Review And Adjustment Notice: This notice informs the Person Receiving Support and the Person Paying Support of their right to request a modification to their existing court order.
- State License Release: This notice informs the Person Paying Support of the release of a state issued license.

Notifications

- Appointments: An email notification 10 days and 2 days before the appointment date for: Appellate Court Hearings, Bankruptcy Court Hearings, Genetic Test Appointments, Interviews, Juvenile Court Hearings, Superior Court Hearings, Worker's Compensation Appeals Board Hearings, Unemployment Insurance Benefit/Disability Insurance Benefit Appeals Board Hearings and State Hearings.
- Payments: An email notification when a payment is sent.
