SUBJECT: FINAL RULE OPTIONAL PROVISIONS - FEDERAL FINANCIAL

PARTICIPATION FOR TRANSPORTATION SERVICE AND EDUCATION

AND OUTREACH ACTIVITIES

REFERENCE: 45 Code of Federal Regulations (CFR) §304.20(b)(3)(v), 45 CFR §304.20(b)(12), The Flexibility, Efficiency, and Modernization in Child Support Enforcement Programs Final Rule (FEM Final Rule).

PURPOSE: To communicate statewide policy to local child support agencies (LCSAs) relative to the availability of Federal Financial Participation (FFP) for transportation and education and outreach activities as outlined in the FEM Final Rule.

POLICY: Each LCSA may, at their discretion, provide minor transportation assistance and education and outreach activities as prescribed in 45 CFR §304.20(b)(3)(v) and 45 CFR §304.20(b)(12) respectively.

BACKGROUND: The Office of Child Support Enforcement (OCSE) published the FEM Final Rule on December 20, 2016. The Final Rule changes federal child support regulations by requiring new mandatory provisions and allowing new optional provisions. This letter addresses optional provisions for:

- Transportation assistance for participation in the establishment and enforcement
  of support orders. LCSAs may determine when minor transportation expenses,
  (e.g., bus fare, taxi reimbursement, or other costs the LCSA deems appropriate),
  should be available to encourage child support customers to participate in child
  support proceedings.
- Educational and outreach activities intended to inform the public, parents, and family members, and young people who are not yet parents about the Child Support Program, responsible parenting and co-parenting, family budgeting, and other financial responsibilities when the parents are not living together.

ACTION: Each LCSA may, at their discretion, provide minor transportation assistance costs as prescribed in 45 CFR §304.20(b)(3)(v). LCSAs may also conduct education and outreach activities as prescribed in 45 CFR §304.20(b)(12).
